**A RESOLUTION OF THE BOARD OF TRUSTEES OF

The Board of Trustees of Hartford Township, Licking County, Ohio, met in an open and properly noticed special meeting on the 4<sup>th</sup> day of August, 2023, for the purpose of naming and appointing a part time employee to assist in the upkeep of the cemetery of the Hartford Cemetery, with the following members of the Board present:

**WHEREAS**, Mr. Rober Callan has retired from his position as Cemetery Sexton of Hartford Township, Licking County, Ohio, effective as of the end of the day on July 31, 2023; and

**WHEREAS**, the Board believes that the Township would benefit from having a part time employee to maintain the cemetery until a full time Cemetery Sexton can be hired.

**WHEREAS**, the part time position would pay \$18.00 per hour with no township benefits or overtime available. The employee would be required to enroll in OPERS.

**WHEREAS**, the said \_\_\_\_\_ is a qualified applicant, and is a person whom the Board of Trustees of the Township has determined is well qualified to carry out the duties and functions of part time Cemetery Sexton; and
