## **RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN MILL LIMITATION 5705.19(G)**

The Board of Township Trustees of Hartford Township, Licking County, Ohio, in their capacity as the taxing authority for the Hartford Township Road District, met in regular session at the Hartford Township House on the 21<sup>st</sup> day of January 2019, with the following members present:

Grandstaff moved the adoption of the following:

### RESOLUTION

BE IT RESOLVED, and it is hereby determined, by the Board of Township Trustees of Hartford Township, Licking County, Ohio, in their capacity as the taxing authority for the Hartford Township Road District, that the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for

the necessary requirements of the Hartford Township Road District, and it is necessary to levy a tax in excess of such ten mill limitation for the purpose of general construction, reconstruction, resurfacing and repair of streets, roads and bridges in the Hartford Township Road District as provided in Section 5705.19(G) of the Ohio Revised Code; and,

BE IT FURTHER RESOLVED that a replacement levy of three (3) mills for each year be placed upon the tax duplicate for such purposes pursuant to Section 5705.19 of the Ohio Revised Code, said levy to be for a period of five years; and,

BE IT FURTHER RESOLVED that said levy be placed upon the tax list beginning with the tax year 2019, and for the tax years 2020, 2021, 2022, and 2023 to be first collected in calendar year 2020; and,

BE IT FURTHER RESOLVED that the question of such levy be submitted to the electors of the Hartford Township Road District, Licking County, Ohio at the same time as the Primary Election, to be held in the usual voting places within said Hartford Township Road District on the 7<sup>th</sup> day of May, 2019; and,

BE IT FURTHER RESOLVED that the form of the ballots cast at such election shall be:

A majority vote shall be necessary for passage.

A replacement of a tax of three (3) mills for the benefit of the Hartford Township Road District, Licking County, Ohio, for the purpose of general construction, reconstruction, resurfacing, and repair of streets, roads and bridges in the Hartford Township Road District at a rate not exceeding three (3) mills for each one dollar of valuation which amounts to thirty cents (\$.30) for each one hundred dollars of valuation for a period of five years commencing in tax year 2019, first due in calendar year 2020.

BE IT FURTHER RESOLVED that the Fiscal Officer of Hartford Township be, and hereby is, directed to certify a copy of this Resolution to the Board of Elections of Licking County, Ohio, along with a copy of the certified information from the Licking County Auditor pursuant to R.C. 5705.03(B) and cause notice of the same to be given as required by law.
